- 1 A tender is invited for the work as mentioned in Appendix 'A' to this **NOTICE INVITING TENDER (NIT)**.
- 2 The work is estimated to cost as indicated in aforesaid Appendix 'A'. This estimate, however, is not a guarantee and is merely given as a rough guide and if the work cost more or less, a tenderer/bidder will have no claim on that account. The tender shall be based on as mentioned in aforesaid Appendix 'A'.
- 3 The work is to be completed within the period as indicated in aforesaid Appendix 'A' in accordance with the phasing, if any, indicated in the tender from the date of handing over site, mentioned in Work Order issued by GE after submission of Performance Security Deposit.
- 4
  - (i) Normally contractors whose names are on the MES approved list for the area in which the work lies, and within whose financial category the estimated amount would fall, may tender/bid but in case of term contracts, contractors of categories SS to E may tender/bid.
  - (ii) In case, the tender submitted by enlisted as well as un-enlisted contractor is accepted, the contractor will be required to lodge "**Performance Security deposit**" for an amount equivalent to 5% of the contract Sum/Lump-Sum in favour of the Accepting officer within 28(Twenty eight) days of the receipt by the contractor of notification of acceptance of his tender/bid in the form of "Bank Guarantee" or FDR or insurance surety bonds. Failure of the contractor to comply with the requirements of Performance Security shall constitute sufficient grounds for cancellation of the award of work and forfeiture of the Earnest Money. In case of MES enlisted contractor, amount equal to the Earnest Money stipulated in the Notice Inviting Tender, shall be notified to the tenderer for depositing the amount through MRO. Irrespective of whatever is mentioned in condition 19.3 of IAFW 2249 with regard to suspension of tenders on account of non-submission of performance security, issue of tenders to such tenderers shall remain suspended for a period of six months from the date of cancellation of contract under condition 19.3 of IAFW 2249 in case of unenlisted contractors. Incase of MES enlisted contractors, issue of tenders shall remain suspended till deposit of EMD or six months from date of cancellation whichever is later.
  - (iii) Not more than one tender/bid shall be submitted/uploaded by one contractor or one firm of contractors. Under no circumstances will a father and his son(s) or other close relations who have business dealing with one another be allowed to tender/bid for the same contract as separate competitors. A breach of this condition will render the tenders/bids of both the parties liable for rejection.
- 5 The **CHIEF ENGINEER SHILLONG ZONE, SPREAD EAGLE FALLS, SHILLONG – 793011** will be the Accepting Officer here in after referred to as such for purpose of the contract.
- 6 The Technical Bid (Cover-1 and Cover-2) shall be uploaded by the tenderer/bidder on or before the date & time mentioned in NIT. A scanned copy of DD with enlistment details/documents shall be uploaded as packet 1/cover-1 ('T' bid) of the tender/bid on e-tendering portal. DD is refundable in case 'T' bid is not accepted resulting in non-opening of 'Q' bid. The applicant contractor shall bear the cost of bank charges for procuring and encashing the DD and shall not have any claim from Government whatsoever on this account.
- 7 **INTEGRITY PACT (IP)** duly signed by Accepting Officer / Officer designated by Accepting Officer is uploaded as part of NIT as Annexure-I of Appendix 'A' to NIT and the same shall form part of tender documents. The scanned copy of INTEGRITY PACT (IP) duly signed on each page by the bidder shall be uploaded in technical bid (cover-1) and original INTEGRITY PACT (IP) duly signed on each page shall be forwarded to this office by post alongwith all other documents as required and mentioned in Appendix 'A' to NIT and Bidders who do not upload scanned copy of IP duly signed, shall be intimated of the same alongwith intimation of other such deficient documents, through option of 'Short Fall Documents' (in e-tendering portal) before 'T' bid evaluation. Any bidder who fails to forward the copy of IP duly signed even after this communication, shall be disqualified in the Technical bid (Cover-I).Tender form and conditions of contract and other necessary documents shall be available on '<http://defproc.gov.in>' web site for download and shall form part of contract agreement in case the tender/bid is accepted.

- 9 In Case of contractor who has not executed the Standing Security Bond, the Cover-1 shall be accompanied with by Earnest Money of amount as mentioned in Appendix 'A' in the form of deposit at call receipt in favour of concerned GE/ GE(I)/ AGE(I) (see Appendix 'A') by a scheduled Bank or in received treasury Challan the amount being credited to the revenue deposit of the concerned GE/ GE(I)/ AGE(I) (see Appendix 'A').
- 10 The bidder whose bid is finally accepted **shall submit performance security as per condition 19 of IAFW-2249** (As amended under amendment No 47 to IAFW- 2249) within the stipulated period failing which action as per provision given in condition 19 shall be taken.
- 11 The GE/GE(I)/AGE(I)/AO will return the Earnest Money wherever applicable to all unsuccessful tenderers/bidders by endorsing an authority on the deposit-at-call receipt for its refund, on production by the tenderer, bidder a certificate of the Accepting Officer that a bonafide tender/bid was received and all documents were returned.
- 12 The GE/ GE(I)/ AGE(I)/AO will either return the Earnest Money to the successful tenderer/bidder by endorsing an authority on the deposit-at-call Receipt for its refund on receipt of an appropriate amount of Security Deposit or will retain the same in part or full on account of security deposit if such a transaction is feasible.
- 13 Copies of the drawings and other document pertaining to the work signed for the purpose of identification by the Accepting Officer or his accredited representative, sample of materials and stores to be supplied by the contractor will also be available for inspection by the tenderer/bidder at the office of Accepting Officer and concerned GE/ GE(I)/ AGE(I) during working hours.
- 14 The tenderers/bidders are advised to visit the site of work by making prior appointment with GE/ GE (I)/ AGE(I) who is also the Executing Agency of the work (see appendix 'A'). The tenderers/bidders are deemed to have full knowledge of all relevant documents, samples, site etc., whether they have inspected them or not.
- 15 Any tender/bid which proposes any alteration to any of the conditions laid down or which proposes any other condition or prescription whatsoever, is liable to be rejected.
- 16 The uploading of bid implies that bidder has read this notice and the Conditions of Contract and has made himself aware of the scope and specification of work to be done and of the conditions and rates at which stores, tools and plants etc will be issued to him and local conditions and other factors having bearing on the execution of the work.
- 17 Tenderers/bidders must be in possession of a copy of the MES Standard Schedule of Rates (see appendix 'A') including amendments and errata thereto.
- 18 Invitation for e-tender does not constitute any guarantee for validation of 'T' bid and subsequent opening of finance bid of any applicant/bidder, even of enlisted contractors of appropriate class, merely by virtue of enclosing DD. Accepting Officer reserves the right to reject the 'T' bid and not open the finance bid of any applicant/bidder. 'T' bid validation shall be decided by the Accepting Officer based on, inter alia, capability of the firm as per criteria given in Appx 'A' to this **NIT**. The applicant contractor/bidder will be informed regarding non-validation of his 'T' bid assigning reasons thereof through the '**<http://defproc.gov.in>**' website. The applicant contractor/bidder if he so desires may appeal to the next higher Engineer authority viz CE Eastern Command on email id [dircontceengrkl-mes@nic.in](mailto:dircontceengrkl-mes@nic.in) with copy to the Accepting Officer on email before the scheduled date of opening of Finance Bid. The decision of the Next Higher Engineer Authority (NHEA) shall be final and binding. The contractor/bidder shall not be entitled for any compensation whatsoever for rejection of his bid.

1. After opening of Cover I, if the number of MES enlisted contractors of eligible class as well as eligible unenlisted contractors, if any, fulfilling the other eligibility criteria given in NIT are less than 7(Seven),applications in respect of MES contractors upto **two classes below** the eligible class shall also be considered subject fulfilment of other eligibility criteria given in the NIT. Therefore MES contractors upto **two class below** may also bid for this tender. However contractors of upto one/**two** class below the eligible class shall not be considered in case their present residual work in hand is more than **five times** their present tendering limit. However in case such contractors fulfil the criteria of upgradation to the stipulated eligible class based on past experience of completed works (individual work experience and/or average annual turnover, as applicable) and financial soundness (solvency/financial soundness and working capital), the ceiling of present residual work will not apply and they will be considered for issue of tender. Such bidders shall upload in their Cover-I bid details of works in hand showing names of work, names of Accepting Officers, Contract amounts, dates of commencement and completion (stipulated) and progress as on bid submission date. Such contractors, if claim to fulfil the criteria of upgradation shall also upload the requisite information/documents in support of upgradation. These details shall be verified by the Tender Issuing Authority from concerned formations in case bids of such contractors are considered for evaluation.

2. In case after opening of Cover I, the number of MES enlisted contractors of eligible class as well as un-enlisted contractors, if any, fulfilling the other eligibility criteria given in NIT, are 7 (Seven) or more, applications of only those one class below the eligible class bidders shall be considered, who have previously completed similar works satisfactorily and are meeting the criteria of upgradation in respect of past experience of completed works (individual work experience and average annual turnover as applicable) and financial soundness (solvency/financial soundness and working capital) as per details given in Manual on Contracts. Therefore such contractors shall upload the requisite information/documents in the Cover-I.

3. Unenlisted contractor shall be considered provided he meets the criteria. Foreign firms shall not be eligible for this tender. However Indian Firms having foreign national/ Indian nationals staying abroad/ Indian national having taken foreign citizenship, as director(s) shall be considered subject to security clearance from the concerned authorities.

4. Contractors enlisted with MES will upload following documents in Cover I for checking eligibility:-

- (a) Application for tender on Firm's letterhead.
- (b) Enlistment letter issued by the Registering Authority duly renewed for the cycle period in vogue.
- (c) Works experience and financial soundness and other necessary documents as applicable as per Para 2 of Notes above for contractors one class below the eligible class.
- (d) Scanned copy of **DD/Bankers Cheque** toward **cost of tender and EMD** instrument in case SSD bond is not signed at the time of registration.
- (e) Scanned copy of **GST registration letter** along with registration number as applicable to be uploaded in cover -1 of e-bid system. **In absence of this Cover-1 shall be liable for rejection.**

(f) Scanned copy of **Integrity Pact (IP) duly signed on each pages** shall be uploaded in cover -1 of e-bid system. **In absence of this, Cover-1 shall be liable for rejection.**

(g) **Documents required in respect of PQC stipulations.**

5. Contractors not enlisted with MES will be required to upload following documents in Cover I for checking eligibility:-

(a) Application for tender on Firms letter/head.

(b) Scanned copy of **DD/Bankers cheque toward cost of tender and Earnest Money Deposit (EMD)** instrument.

(c) Copy of Police Verification Report/Police Clearance Certificate/Character Certificate from the Police Authority of the area where the registered office of the firm is located/notarized copy of valid passport of Proprietor/each Partner/each Director.

(d) All documents required for enlistment in MES for the class mentioned in Para 8(B) above as per Para 1.5 of Section 1 of MES Manual on Contracts 2020.

(e) Details of works being executed in MES, if any.

(f) Scanned copy of **GST registration letter** along with registration number as applicable to be uploaded in cover -1 of e-bid system. **In absence of this Cover-1 shall be liable for rejection.**

(g) Scanned copy of **Integrity Pact (IP) duly signed on each pages** shall be uploaded in cover -1 of e-bid system. **In absence of this, Cover-1 shall be liable for rejection.**

(h) **Documents required in respect of PQC stipulations.**

6. Tenders not accompanied by scanned copies of requisite DD/Bankers Cheque towards cost of tender and earnest money (as applicable) in Cover I shall not be considered for validation of 'T' bid and their Financial Bids will not be opened.

7. Contractors should ensure that their **original physical DDs and Earnest Money Deposit (EMD)** instruments (as applicable) reach the officer of Accepting Officer **within Five days** of bid submission end date failing which following action shall be taken.

(a) In case of tenders from an enlisted contractor of MES, where scanned copies of requisite DD/Bankers Cheque towards cost of tender have been uploaded in Cover 1 but physical copies are not received within the stipulated period, their financial bids (Cover 2) will be opened. However non-submission of physical copies of cost of tender shall be considered as willful negligence of the tenderer with ulterior motives and such tenderer shall be banned from bidding for a period of six months commencing from the date of opening of Financial Bid (Cover 2).

(b) In case of tenders from unenlisted contractor, where scanned copies of requisite DD/Bankers Cheque towards cost of tender have been uploaded in Cover 1 but physical copies are not received within the stipulated period, their financial bids (Cover 2) will not be opened. Name of such contractors along with complete address shall be circulated for not opening of their bids for a period of six months commencing from the date of opening of Financial bid (Cover 2).

(c) In case of tenders from enlisted and unenlisted contractors, where scanned copies of instruments for Earnest Money Deposit (as applicable) have been uploaded in Cover-I but the same are not received in physical form within stipulated period, such tenders shall not qualify for opening of financial bid (Cover 2)

8. Contractor will not be allowed to execute the work by subletting or through power of attorney to a third party/another firm on his behalf. However a contractor can execute the work through power of attorney to sons/daughters/spouse of Proprietor/Partner/Director and firm's own employees, director, project manager **provided they are not having a separate enlisted firm in MES in their name as Proprietor/Partner/Director.**

9. After opening of Cover I and during its technical evaluation, in case any deficiency is noticed in the documents required to be uploaded by the tenderers as per NIT, a communication in the form of email/SMS/Speed Post etc shall be sent to the contractor to rectify the deficiency within a period of seven days from date of communication failing which their financial bid (Cover 2) shall not be opened and contractor shall not have any claim on the same.

10. Invitation for e-tender does not constitute any guarantee for validation of Technical bid and subsequent opening of financial bid of any applicant/bidder merely by virtue of enclosing DD, Accepting Officer reserves the right to reject the Technical bid and not to open the financial bid of any applicant/bidder, Technical bid validation shall be decided by the Accepting Officer based on eligibility of the firm as per criteria given in this Appendix. Tenderer/bidder will be informed regarding non-validation of his Technical bid assigning reasons therefore, through tender evaluation report which shall be uploaded on the website, Such tenderer, if desires, may appeal to the next higher Engineer Authority (NHEA) i.e HQ CE Eastern Command on email [ceengrkl-mes@nic.in](mailto:ceengrkl-mes@nic.in) or [jtdgconceengrkl-mes@nic.in](mailto:jtdgconceengrkl-mes@nic.in) with copy to the Accepting Officer on email before the scheduled date of opening of Cover 2, NHEA shall decide the matter within a period of seven working days from the date of receipt of appeal. The decision of the NHEA shall be final and binding. The tenderer/bidder shall not be entitled for any compensation whatsoever for rejection of his bid.

11. Unlisted contractor who have secured two work in MES should get themselves registered in the appropriate designated Class with any registering authority, else the firm will not be eligible for participation in the tender unless until the firm is enlisted with the MES.

12. In case the BOQ is revised through the corrigendum and the bidder has failed to quote on revised BOQ (ie he has quoted on pre revised BOQ), such bid shall be treated as willful negligence by the bidder and his quotation shall be considered non-bonafied. In such cases the lowest tender shall be determined from amongst the valid/bonafied bids only. Accepting Officer may decide whether to re-tender or consider the lowest bonafied tender for acceptance.

13. Revoking the offer or revising the rates upward or offering voluntary reduction by the lowest tenderer after opening of Cover 2 shall be considered as willful default. For this default a penalty of an amount equal to Earnest Money shall be levied. In case of an unenlisted tenderer, Earnest Money deposited by him shall be forfeited. In case of MES enlisted tenderer having deposited the Standing Security Bond, an amount equal to the earnest money stipulated in the NIT shall be notified to the tenderer for depositing through MRO and consideration of such tenderer in tender evaluation for future works shall remain suspended till the aforementioned amount is deposited in the Government Treasury, No other disciplinary/administrative action shall be taken against such tenderers. In such a situation, the next lowest offer shall not be considered for acceptance. Instead, retendering shall be resorted to in a transparent and fair manner and the defaulting tenderer and his related firm if any, shall not be eligible for this tender in second call or subsequent calls.

14. Tender to related firms shall not be issued simultaneously, Firms shall be termed as related if Propreitor/one or more Partners/Directors are common. Decision of Accepting Officer on issue/deny the tender to any one of the related firms shall be final and binding.

15. **Performance Security** : Please refer condition 19 of IAFW-2249 (As amended under amendment No 47 to IAFW- 2249).

16. All disputes arising out of or in respect of this tender before acceptance shall be decided by Court of appropriate jurisdiction at **Shillong** only. After acceptance of tender, Condition 72 (Jurisdiction of Courts) of IAFW – 2249 shall be applicable.

Whereas the President of India, represented by Chief Engineer, HQ Chief Engineer Shillong Zone, Spread Eagle Falls, Shillong – 793 011hereinafter referred to as '**Principal / Owner**' and the first part, has floated the Tender (**CA NO: CESZ/RANG/ OF 2025-2026**) and intends to award, under laid down organizational procedure, contract for **PROVISION OF ROOF TOP SOLAR PLANTS TOTALLING 1100 KW AT CERTAIN BLDGS AT RANGAPAHAR MIL STN UNDER GE 868 EWS (CA NO: CESZ/RANG/ OF 2025-2026)** hereinafter referee to as works / Services and M/s.....

.....represented by, .....(which term unless expressly indicated by the contract, shall be deemed to include its successors and its assignees), hereinafter referred to as the Bidder / Contractor and the second part is willing to carryout the works / services.

1. Whereas the Bidder is a Proprietorship Concern / Partnership Firm / Limited Liability Firm / Privet Limited Company / Limited Company / Joint Venture constituted in accordance with the relevant law in the matter and the Principal / Owner is Chief Engineer (CE) performing its functions on behalf of the President of India.

**OBJECTIVES**

2. Now, therefore, the Principal / Owner and the Bidder agree to enter into this pre-contract agreement, referred to as **INTEGRITY PACT(IP)**, to avoid all forms of corruption by following a system that is fair, transparent and free from any influence / prejudiced dealings prior to, during and subsequent to conclusion of the contract to be entered into with a view to:-

- 2.1. Enabling the Principal / Owner to get the desired works / services at a competitive price in conformity with the defined specifications of the services by avoiding high cost and the distortionary impact of corruption on public procurement.
- 2.2. Enabling Bidders to abstain from bribing or any corrupt practice in order to secure the contract by providing assurance to them that their competitors will also refrain from bribing and other corrupt practices and the Principal / Owner will commit to prevent corruption, in any form, by their officials by following transparent procedures.

**COMMITMENTS OF THE PRINCIPAL / OWNER**

3. The Principal / Owner commits itself to the following:-

3.1. The Principal / Owner undertakes that, no official of the Principal / Owner, connected directly or indirectly with the contract will demand, take a promise for or accept, directly or through intermediaries, any bribe, consideration, gift, reward, favor or any material or for any person, organization or third party related to the contract; in exchange for an advantage; in the bidding process, bid evaluation, contracting or implementation process related to the Contract.

3.2. The Principal / Owner will, during the pre-contract stage, treat all Bidders alike and will provide to all Bidders the same information and will not provide any such information to any particular Bidder which could afford an advantage to that particular Bidder in comparison to other Bidders.

4. In case of any such preceding misconduct on the part of such official(s) is reported by the Bidder to the Principal / Owner willful and verifiable facts and the same is *prima facie* found to be corrected by the Principal / Owner, necessary disciplinary proceedings, or any other action as deemed fit, including criminal proceedings may be initiated by the Principal / Owner and such a person shall be debarred from further dealing related to the tender / contract process. In such a case while an Inquiry is being conducted by the Principal / Owner the tender process / proceedings under the contract would not be stalled.

**COMMITMENTS OF BIDDERS**

5. The Bidder commits himself to take all measures necessary to prevent corrupt practices, unfair means and illegal activities during any stage of his bid or during any pre-contract or post-contract stage in order to secure the contract or in furtherance to secure it and in particular commits himself to the following:-

5.1. Bidder will not offer, directly or through intermediaries, any bribe, gift, consideration, reward, favor any material or non-material benefit or other advantage, commission, fee, brokerage or inducement to any official of the Principal / Owner, connected directly or indirectly with the bidding process, or to any person, organization or third party related to the contract in exchange for any advantage in the bidding, evaluation, contracting and implementation of the Contract.

5.2. The bidder further undertakes that he has not given, offered or promised to give, directly or indirectly any bribe, gift, consideration, reward, favour any material or non-material benefits or other advantage, commission, fees, brokerage or inducement to any official of the Principal / Owner or otherwise in procuring the Contract or forbearing to do or having done any act in relation to the obtaining or execution of the contract or any other Contract with the Government for showing or forbearing to show favor or disfavor to any person in relation to the Contract or any other Contract with the Government.

5.3. The bidder will not collude with other parties interested in the contract to impair the transparency, fairness and progress of the bidding process, bid evaluation, contracting and implementation of the contract.

5.4. The bidder will not accept any advantage in exchange for any corrupt practice, unfair mean and illegal activities.

5.5. The bidder would not enter into conditional contract with any Agent(s), broker(s) or any other intermediaries wherein payment is made or penalty is levied, directly or indirectly, on success or failure of the award of the contract.

5.6. The Bidder commits to refrain from giving any complaint directly or through any other manner without supporting it with full and verifiable facts. Complaint will be processed as per **Guidelines for Handling of Complaints** in vogue. In case the complaint is found to be vexatious, frivolous or malicious in nature, it would be construed as a violation of Integrity Pact.

6. **PREVIOUS TRANSGRESSION**

6.1. The Bidder declares that no previous transgression occurred in the last three years immediately before signing of this Integrity Pact with any other company in respect of any corrupt practices envisaged hereunder or with any Public Sector Enterprise in India or any Government Department in India.

6.2. If the Bidder makes incorrect statement on this subject, Bidder can be disqualified from tender process or the contract and if already awarded, same can be terminated for such reason.

7. **COMPANY CODE OF CONDUCT**

7.1. Bidder are advised to have a company code of conduct (clearly rejecting the use of bribes and other unethical behavior) and a compliance program for the implementation of the code of conduct throughout the country.

8. **SANCTION FOR VIOLATION**

8.1. Any breach of the aforesaid provisions by the Bidder or any one employed by him or acting on his behalf (whether with or without the knowledge of the Bidder) or the commission of any offence by the Bidder or any one employed by him or acting on his behalf, as defined in Chapter IX of the Indian Penal Code, 1860 or the Prevention of Corruption Act 1988 or any other act enacted for the prevention of corruption shall entitle the Principal / Owner to take all or any one of the following actions, wherever required:-

- (i) Technical bid of the Bidder will not be opened. Bidder will not be entitled to or give any compensation. However, the proceedings with the other Bidder(s) would continue.
- (ii) Financial bid of the Bidder will not be opened. Bidder will not be entitled to or give any compensation. However, the proceedings with the other Bidder(s) would continue.
- (iii) The Earnest Money Deposit shall stand forfeited either fully or partially, as decided by the Principal / Owner, in case contract is not awarded to the Bidder and the Principal / Owner shall not be required to assign any reason therefore. For enlisted contractors an amount less than or equal to Earnest Money Deposit as decided by the Principal / Owner shall be deducted from any amount held with the Department / any payment due.
- (iv) To immediately cancel the contract, if already concluded / awarded without any compensation to the Bidder.
- (v) To encash the Performance Security furnished by the Bidder.
- (vi) To cancel all or any other Contract(s) with the Bidder.
- (vii) To temporarily suspend or temporarily debar / permanently debar the bidder as per the extant policy.
- (viii) If adequate amount is not available in the present tender / contract, the deficient amount can be recovered from any outstanding payment due to the Bidder from the Principal / Owner in connection with any other contract for any other works / services.
- (ix) If the Bidder or any employee of the Bidder or any person acting on behalf of the Bidder, either directly or indirectly, is closely related to any of the officers of the Principal / Owner, or alternatively if any close relative of an officer of the Principal / Owner has financial interest / stake in the Bidder's firm, the same shall be disclosed by the Bidder at the time of submission of tender. Any failure to disclose the interest involved shall entitle the Principal / Owner to debar the Bidder from the bid process or rescind the contract without payment of any compensation to the Bidder. The term 'close relative' for this purpose would mean spouse whether residing with the Government servant or not, but does not include a spouse separated from the Government servant by a decree or order of a competent Court; son or daughter or step son or step daughter and wholly dependent upon Government servant, but does not include a child or a step child who is no longer in any way dependent upon the Government servant or of whose custody the Government servant has been deprived of by or under any law; any other person related, whether by blood or marriage, to the Govt servant or to the Government servant's wife or husband and wholly dependent upon Government servant.
- (x) The Bidder shall not lend to or borrow any money from or enter into any monetary dealings or transactions, directly or indirectly, with any employee of the Principal / Owner and if he does so the Principal / Owner shall be entitle forthwith to cancel the contract and all other contracts with the Bidder.

8.2. The decision of the Principal / Owner to the effect that a breach of the provisions of this Integrity Pact has been committed by the Bidder shall be final and binding on the Bidder. **However, the Bidder can approach the Independent External Monitor(s) (IEMs) appointed for the purposes of this Pact.**

9.3. In case of any complaint with regard to violation of Integrity Pact, either party can approach IEMs with copy to the Nodal Officer and the other party. If any such complaint from bidder is received by the Principal / Owner, the Principal / Owner shall refer the complaint to the Independent External Monitors for their recommendations / inquiry report.

9.4. If the IEMs need to peruse the relevant records of the Principal / Owner and /or of the Bidder / Contractor in connection with the complaint sent to them, the Principal / Owner and/or the Bidder/ Contractor shall make arrangement for such perusal of records by the IEMs as demanded by them including unrestricted and unconditional access to the project documentation and minutes of meeting. If records / documents of Sub-Contractor(s) are also required to be perused by the IEMs, the Bidder shall make arrangement for such perusal of records by the IEMs as demanded by them. IEMs are under obligation to treat the information and documents of the Principal / Owner and Bidder / Contractor / Sub-Contractors with confidentiality.

9.5. The task of the IEMs, is to review independently and objectively, any complaint received with regard to violation Integrity Pact and offer recommendations or carry out inquiry as deemed fit. The IEMs are not subject to any instructions by the representatives of the parties and shall perform their functions neutrally and independently. The report of inquiry, if any, made by the IEMs shall be submitted to either of the following for a final and appropriate decision in the matter keeping in view the provision of this Pact:-

- (a) Engineer-in-Chief in normal cases
- (b) CVO (MES & BRO) / MoD in cases involving vigilance angle

10. **EXAMINATION OF BOOKS OF ACCOUNTS**

In case of any allegation of violation of any provisions of this Integrity Pact or payment of commission, the Principal / Owner or its agencies shall be entitled to examine the Books of Account of the Bidder and the Bidder shall provide necessary information of the relevant financial documents in English and shall extend all possible help for the purpose of such examination.

11. **LAW AND PLACE OF JURISDICTION**

This Pact is subject to Indian Law. The place of performance and jurisdiction is the seat of the Principal / Owner.

12. **OTHER LEGAL ACTIONS**

The actions stipulated in this Integrity Pact are without prejudice to any other legal action that may follow in accordance with the provisions of the extant law in force relating to any civil or criminal proceedings.

13. **SIGNING OF INTEGRITY PACT ON BEHALF OF BIDDER**

- (a) **Proprietorship Concern** - The Integrity Pact must be signed by the proprietor or by an authorised signatory holding power of attorney signed by the proprietor.
- (b) **Partnership firm** - The Integrity Pact must be signed by all partners or by one or more partner holding power of attorney signed by all partners.
- (c) **Limited Liability firm** - The Integrity Pact must be signed by all partners or by one or more partner holding power of attorney signed by all partners.
- (d) **Private Limited/Limited Company** - The Integrity Pact must be signed by a representative duly authorised by Board resolution.
- (e) **Joint Venture** - The Integrity Pact must be signed by all partners and members to Joint Venture or by one or more partner holding power of attorney signed by all partners and members to the Joint Venture.

14. **Validity**

14.1. The validity of this Integrity Pact shall be from date of its signing. It expires for the Contractor after the final payment under the contract has been made or till the continuation of Defect Liability Period, whichever is later and for all other bidders, till the Contract has been awarded.

14.2. Should one or several provisions of this Pact turn out to be invalid; the remainder of this Pact remains valid. In this case, the parties will strive to come to an agreement to their original intentions.

### **PROVISIONS OF JOINT VENTURE**

1. Joint venture (JV) shall not comprise more than two firms (called parties of JV). The lead party shall have at least 60% share of interest in the JV. The other than lead party shall have at least 30% share of interest in the JV. The format of agreement is at Annexure-III. The JV shall be considered as un-enlisted contractor. The JV shall submit Earnest Money Deposit for all tenders mandatorily. Any bid received from JV firm without EMD shall be considered as non-bonafide tender.
2. A valid agreement shall exist between the parties of JV defining clearly the role, responsibility and scope of work of each party, percentage share of each party along with nomination of leader (Lead Party) for the purpose of this work and a confirmation that the parties of the JV are jointly and severally responsible.
3.
  - a) Foreign Companies shall not be permitted to participate in JV.
  - b) Indian Companies having Director(s) of foreign origin and Indian Companies having Director(s) of Indian origin but residing abroad / having foreign citizenship shall be permitted to participate in JV. However, security clearance in such cases shall be obtained by following procedure laid down by Ministry of Home Affairs.
  - c) Case for security clearance shall be processed to E-in-C's Branch on PRIORITY after opening 'T' bid (Cover-1). Further, processing of tender to open Finance Bid (Cover-2) shall not be held up awaiting receipt of security clearance. However, if the JV requiring security clearance of Director(s) becomes L1, the tender shall be accepted only on receipt of security clearance. For this, the Accepting Officer will pursue the security clearance vigorously.
4. JV as a single unit or each party of the JV shall have Permanent Account Number (PAN) and GSTIN. However, if the contract is awarded to the JV, then PAN & GSTIN shall be obtained by the JV as a single unit.
5. Parties to the JV shall meet the following laid down criteria for the purpose of forming JV:-

- (i) The JV shall collectively meet the working capital criteria as contained in the NIT/Tender documents.
- (ii) The JV shall collectively meet the Bank solvency/Financial soundness for engagement criteria as contained in the NIT/Tender documents.

6. Both the parties to the JV either individually (single entity of the JV) or collectively (lead and other than lead) shall fulfill the 100% of the Technical qualifying criteria as stipulated in the NIT/Tender documents.
7. Both the Parties of JV shall jointly possess the required T&P, machinery and engineering/supervisory staff. T&P can be either on ownership basis or leasehold as stipulated in NIT/tender documents and documentary proof of the same shall be submitted.

8. JV concluded up to the date of bid submission are permitted to apply. Copy of JV should be uploaded alongwith Technical Bid (Cover-I). If any information furnished by the applicant JV is found incorrect and/or misleading and / or false representation and/or deliberately suppressed information, at a later stage, the JV and both the parties shall be liable to be debarred from tendering/taking up of any work in MES.

9. Party/ parties will not be allowed to bid for the same tender in their independent capacity as well as under JV. Also no party will be allowed to bid for the same tender under multiple JVs. - c) This Agreement is the legal and binding obligation of such Party, enforceable in accordance with its terms against it; and
- d) There is no litigation pending or, to the best of such Party's knowledge, threatened to which it or any of its Affiliates is a Party that presently affects or which would have a material adverse effect on the financial condition or prospects or business of such Party in the fulfilment of its obligations under this Agreement.

#### **9. Termination**

This Agreement shall be effective from the date hereof and shall continue in full force and effect until completion of Defect Liability Period under and in accordance with the Contract, in case the Project is awarded to the Joint Venture. However, in case the Joint Venture does not pre-qualify for the Project or does not get selected for award of the Project, the Agreement will stand terminated in case the Applicant does not pre-qualify or upon return of the Bid Security/Earnest Money Deposit by the Authority to the Bidder, as the case, may be.

#### **10. Miscellaneous**

- a) This Joint Bidding Agreement shall be governed by Laws of India.
- b) The Parties acknowledge and accept that this Agreement shall not be amended by the Parties without the prior written consent of the Authority.
